The Wedding Day - Photography

The service that we offer is complete and provides you with a full record of your wedding with plenty of fun shots that capture your day!

We thoroughly enjoy wedding photography and have a passion and desire to achieve a great selection of photos, which tell the story of your biggest day.

Our approach is a mixture of reportage (photo journalistic) and traditional photography. Although the majority of your images will be candid, storytelling images; we recommend having at least some informal family group shots, as this is a once in a lifetime event with everyone coming together in one place.

The checklist for photographs we give you, once filled, will give us all the information we need to prepare for the day, so that you can relax and let the events unfold. For example; bride getting ready, guests arriving, groom and best man enjoying a last drink etc.

If possible it is also good for us to have a schedule of your day so that we can keep track of timings you have in place, i.e. brides arrival at ceremony, arrival at reception, wedding breakfast start time etc. Please use our wedding checklist to help you.

top tip: 'a good plan will leave you free to enjoy your day with no worries'

So from start to finish (according to the times we agree on) we will be there, unobtrusively capturing the spirit of the day and all the moments that make it unique to you.

The only time we don't advise photographs, is during meal times when people would rather be left alone, at this point we will hang back, although we will be on hand just in case and so as not to lose momentum.

As soon as coffee is served, we start shooting again and will photograph the speeches, cake cutting and the first dance (if agreed).

What happens next?

Once the shoot has finished all images are professionally edited. We aim to get these ready for when you return from your honeymoon.

You will then be sent an email with a link to an online password protected web gallery, enabling you to decide in your own time at home which images you would like as part of your package.

Your selection of images are then printed using the highest quality printing methods. Further prints can be added to your order for relatives and friends. Plus options to create thank you cards, framed photographs, leather bound albums, image books and more.

The Wedding Day - Videography

Having a wedding video made of your special day is a great way to really remember it years later. Video captures the things photos can't; like the bride and groom walking up the aisle coupled with the guest's reactions, the jokes and laughter from all of the speeches.

We don't aim to capture every individual moment of your wedding and give you a ton of footage. Instead, we tailor our approach to your needs and focus on capturing what is important to you. We will create a wonderful film through which you can relive your wedding day each and every time you watch it.

We always use two camera operators to film your day, this is essential and means we can cut between shots and ensures the final edit looks great. We use a discreet approach so you and your guests hardly notice us.

Everyone is unique in their requirements for their wedding video so we really value your input throughout the process of creating it.

What happens next?

Once we finish filming your wedding we back everything up so all the footage is safe and sound.

After your honeymoon, when you've had a chance to relax we will get in touch and have a discussion about your favourite parts of the wedding.

We create a 'rough cut' of the film for you to have a look at. This is the time for you to decide on any minor changes and make suggestions. A final edit is created afterwards and given to you on a personalised usb and dvd. You will also receive a link to an online version to your video so you can share it with your family and friends.

The whole editing process takes up to six weeks to ensure high production values. It is never too late to decide to upgrade your package if you want to have the full-length service and speeches video.

top 5 wedding tips

1. Relax! The best photographs are those where the bride and groom are at ease. You have spent so long planning your big day and probably made sure that your friends and family all have a job - now leave it to them and enjoy yourself and your personality will shine through in the shots!



3. Practice There's nothing wrong with having a little practice. You will be wearing a very important dress on the day (or suit) and you want to wear it well - maybe take a look in some wedding magazines at how other couples have photographed and see what works for you? However don't get too 'posey' - the more natural the better - its about you!

4. Organise This applies mainly to the group shots. Time is short at weddings for line ups and so a tight ship is in required! Perhaps nominate an usher or two to be in charge of gathering together the friends and family to the group photographs. This will allow us to concentrate on arranging everyone and achieve the best shots.



5. Special Guests

Obviously everybody is important at your wedding, however you may have certain friends or family who you just *have* to have a shot of on the day. Make sure that they are included in the group shots or maybe make a special effort to have a separate photograph with them. Remember, you know who these people are and not your photographer - so be sure to point them out!

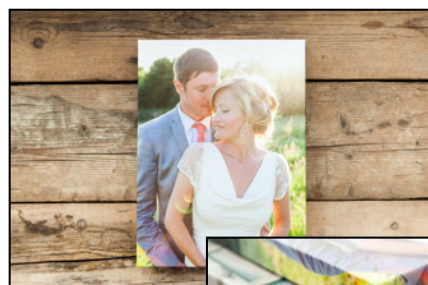

Wedding Agreement Terms & conditions

1. Exclusive Photographer/Videographer

The Photographer/videographer shall be the exclusive photographer/videographer retained by the Client for the purpose of capturing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the photographer's/videographers duties and do not photograph poses arranged by the photographer or videographer.

2. Deposit and Payment.

The Client shall make a deposit to retain 'Studio 8' to perform the services specified herein. At such time as this order is completed, the deposit shall be applied to reduce the total cost and Client shall pay the balance due. The deposit is non-refundable. If the Client refuses delivery of the order/service or refuses to pay within thirty 30 days of this order/booking, Client shall be in default hereunder and shall pay 6.5 percent interest on the unpaid balance until payment is made in full.

3. Cancellation.

The deposit is non- refundable. Cancellations up to 45 days before the wedding will be subject to 50% of the final payment due. Full payment will be due for cancellations after the 45th day before the wedding.

4. Photographic/Video Materials. All photographic materials, including but not limited to negatives, memory cards, transparencies, hard drives, proofs, and previews, shall be the exclusive property of the Photographer/videographer. The Photographer may make previews available to the client for the purpose of selecting photographs, but such proofs and previews shall be on loan and, if they are not returned within fourteen (14) days of receipt by the Client, shall be charged to the Client at the same rate as finished prints of the same size. An online preview of the photos/video will be issued to the client only when payment is made in full for the chosen option.

5. Copyright and Reproductions.

'studio 8' retain full, unlimited, world-wide copyright on all photographs/video supplied. These photographs are solely for personal display purposes. They may not be copied, published, reproduced, or stored on any electronic retrieval system without the express written permission of 'Studio 8' or upon purchase of the digital files. 'Studio 8' shall only make reproductions for the Client or for 'Studio 8's' portfolio, samples, self-promotions, entry in photographic/video contests or art exhibitions, editorial use, website or for display within or on the outside of the Photographer's studio. If 'Studio 8's' desires to make other uses, 'Studio 8's' shall not do so without first obtaining the written permission of the Client. 'Studio 8' may wish to release copyright or reproduction rights for the images for an agreed amount, which may not be passed to any third party whatsoever. In such event, Client shall request that a credit for 'Studio 8's' be placed adjacent to the photograph on any publication that the images are used within, but shall have no liability if the publication refuses or omits to do so.

6. Failure to Perform

If 'Studio 8's' cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to 'Studio 8's' illness, then 'Studio 8's' shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic/video graphic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of 'Studio 8's'. In the event 'Studio 8's' fails to perform for any other reason, 'Studio 8's' shall not be liable for any amount in excess of the retail value of the Client's order.

7. Photographer/Videographer

The photographer/videographer may substitute another photographer/videographer to take the photographs/video in the event of Photographer's/videographers illness or of scheduling conflicts. In the event of such substitution, photographer/videographer warrants that the photographer/videographer taking the photographs/video shall be a competent professional.

8. Inherent Qualities.

Client is aware that colour dyes in photography may fade or discolour over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discolouration due to such inherent qualities.

9. Studio8'Standard Price List.

The charges in this Agreement are based on Studio8's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

10. Match to original. (Likeness to person/colour). In accordance with the accepted practices of all professional photographers and photographic laboratories, the return of any technically acceptable photographs or prints or demands for refund or refusal to settle charges cannot be entertained on principle. No exception whatsoever can be made to this rule as we cannot be held responsible for individual tastes or expectations.

11. Miscellany.

This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of England and Wales.
